Sun Safety Policy

At St. Charles Borromeo Catholic Primary School in accordance with our Mission Statement, we aim to work in partnership with parents/carers and the whole school community to ensure safety in the sun. We will seek to educate and give the children high quality learning experiences based on sun safety.

This policy should be read in conjunction with our Health and Safety Policy.

AIMS

- To protect staff and pupils from excessive sun exposure
- To raise awareness of the dangers of excessive sun exposure
- To promote sun safety through a range of interesting and exciting learning experiences
- To encourage staff and pupils to keep well hydrated.

OBJECTIVES

In order to achieve these aims we will:

- provide activities as part of our PSHE curriculum on sun safety, linking to other areas of the curriculum where possible
- encourage parents to apply sun cream to their children before school. Sun cream will be available in school should children need to re-apply it
- encourage children to bring in their own water bottles and to drink water throughout the day
- encourage the children to wear sun hats / caps when outside in sunny weather
- where possible, provide shaded areas for pupils on the playground / school playing field
- allow the children to be as comfortable as possible during times of excessive heat.

ORGANISATION

- In very hot weather, indoor play will be provided for the children
- At the Head Teacher's discretion school ties may be removed during very hot weather
- During educational visits in very hot weather additional supplies of water will be provided
- PE kits may be recommended during days where there is excessive heat

Sun Safety Policy

• A proforma will be included in the school welcome pack to seek permission from parents for staff to supervise the application of sun cream.

RESOURCES

- Resources for teaching Sun Safety can be found on the school server
- School caps are available to buy from the school uniform supplier
- Each class will be issued with a bottle of sun cream
- Storage will be provided for water bottles

HEALTH AND SAFETY

It is the responsibility of the parents to change the water for their child daily. It is also the parents' responsibility to provide a hat on sunny days.

Water bottles should not be stored or used near electrical equipment
