School Attendance

This is a reminder that If you take your child(ren) out of school without authority, you may be liable to receive a penalty notice. Currently the amount payable under a penalty notice is £60.00 per parent/carer per child if paid within 21 days. Thereafter the amount increases to £120.00 if paid between 21 and 28 days. If the penalty notice remains unpaid after 28 days, the Local Authority will consider a prosecution in the Magistrates Court. Please note that penalty notices are issued per parent/carer per child so a family of two parents and two children will receive 4 penalty notices. Please note that this does not apply to funerals, medical appointments etc.




Netball

Covid Update

We have been advised by Surrey that from a school point of view the following actions should be noted:

The latest guidance from the government is in force up to April 1st when the rules will then change slightly to reflect there is no more free testing. We have therefore been advised to operate in line with the latest Surrey guidance which is summarised below: Pupils/Students and staff should attend if they are well

Pupils/Students and staff should stay at home if they are unwell

If you have COVID-19 symptoms, seek a PCR Test (available until end March 2022) and if positive, stay at home for 5 full days then continue to follow guidance regarding testing.

Other things to note are :

Asymptomatic testing programme in schools has now stopped, no more test kits will be provided but there is a contingency plan at DfE to reinstate testing if cases flare again

Free testing for the general public, both LFT and PCR will cease on April 1st

Close contacts of positive Covid cases are expected to attend school as long as they are well enough to do so.

Should circumstances change I will let you know. I think the key message is to keep being careful and mindful of others. To be fair to everyone, you have done this throughout the pandemic. We have updated our Covid risk assessment in light of the new guidance, we are currently on Version 18!

A proposed change to the school uniform for September

I met with the governors at St Charles to discuss a small but important change to the school uniform provision for September. Any proposed changes to the school uniform should be shared with parents prior to approval in case of any strong objections. I am proposing that from September, girls will be permitted to wear school trousers to school. If you object to the following proposal please let me know via email to <u>mrholt@stcharlesb.surrey.sch.uk</u> by Friday 18th March and I will feedback to the governing body. Assuming we get the ok to proceed we will be in contact with parents regarding the appropriate style and colour of school trousers that can be worn by the girls.

An addition to the School's Behaviour Policy

All schools have needed to make an adjustment to their behaviour policies in line with the duty on schools to address new exclusion regulations. I would want to stress that exclusion (the DFE's term, not mine) is always a last resort. I copy below the addition to the policy that you need to be aware of:

Exclusion

A decision to exclude, either internally, for a fixed-period (referred to as a suspension) or permanently will only be considered when alternative options have been explored. We will make every effort to meet the needs of all pupils and ensure a range of strategies have been used to address inappropriate behaviour. However, we recognise that in some serious situations, exclusion may be necessary.

A serious offence could by itself justify a pupil's exclusion e.g.

- \cdot Violence towards an adult or pupil
- \cdot Any form of peer-on-peer abuse
- · Sustained bullying
- · Frequent high-level disruption to lessons
- · Frequent high levels of non-compliance

If the Headteacher is considering exclusion, he/she will follow the most recent Exclusion Guidance: Exclusion from maintained schools, academies and pupil referral units in England (publishing.service.gov.uk)

Internal exclusion is when a pupil is withdrawn from class for a limited period of time, supervised by a member of staff in another part of the school whilst completing school work. The length of the internal exclusion will be proportionate to the behaviour. Parents/carers will be informed when an internal exclusion is issued. The pupil will have access to movement breaks, toilet facilities, water and snacks/lunch.

Suspension is when a pupil is excluded from school and must remain at home for a fixed period of time. Suspension will only be used for serious breaches of the behaviour policy.

Permanent exclusion is the most serious sanction a school can give. Permanent exclusion will always be a last resort and will only be used in response to a serious breach, or persistent breaches of the behaviour policy.
